Total Uninstall End User License Agreement

NOTICE TO USER: PLEASE READ THIS AGREEMENT CAREFULLY. BY COPYING, INSTALLING OR USING ALL OR ANY POR-TION OF THE SOFTWARE YOU ACCEPT ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT. YOU AGREE THAT THIS AGREEMENT IS LIKE ANY WRITTEN NEGOTIATED AGREEMENT SIGNED BY YOU. THIS AGREEMENT IS ENFORCE-ABLE AGAINST YOU AND ANY LEGAL ENTITY THAT OBTAINED THE SOFTWARE AND ON WHOSE BEHALF IT IS USED: FOR EXAMPLE, IF APPLICABLE, YOUR EMPLOYER. BY DOWNLOADING AND USING THIS SOFTWARE, YOU REPRESENT AND WARRANT THAT YOU HAVE THE AUTHORITY TO BIND THE ENTITY ON WHOSE BEHALF THE SOFTWARE IS USED. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT USE THE SOFTWARE.

1. DEFINITIONS

"YOU" means the company, entity or individual whose funds are used to pay the license fee.

"USE" means storing, loading, installing, executing or displaying the SOFTWARE. You may not modify the SOFT-WARE or disable any licensing or control features of the SOFTWARE except as an intended part of the SOFT-WARE's programming features. This license is not transferable to another organization or individual.

"COMPUTER" means a single physical or virtual machine containing one operating system. Each additional installed operating system on the machine in multiboot configuration counts as one additional computer. The computer must not be used concurrently by more than one user if it is not specified otherwise in the license type.

"SITE" is defined as a restricted area (e.g. campus, premises) of which the diameter does not exceed 10 kilometers, and which is used exclusively by YOU.

2. LICENSE GRANT

License types issued for Total Uninstall:

2.1 Single Computer License

Gavrila Martau grants you a license to use this SOFTWARE on a single COMPUTER.

2.2 Family License

Gavrila Martau grants you a license to use this SOFTWARE on maximum 4 COMPUTERs as long as those computers are located in the same household. The SOFTWARE can be used on mobile computers that are located outside of the household only if these are owned by YOU. This license does not extend to business, commercial and academic users. The license key is not accepted on computers running the operating system server editions or on computers joined to a NT domain. We reserve the right to cancel any family license used in a business environment or registered with a company name.

2.3 Small Office License

Gavrila Martau grants you a license to use this SOFTWARE on maximum 4 COMPUTERs as long as those computers are located in the same building. The SOFTWARE can be used on mobile computers that are located outside of the building only if these are owned by YOU.

2.4 Multiple Computers License

Gavrila Martau grants you a license to use this SOFTWARE on the same number of computers as specified at purchase time.

2.5 Technician license

Gavrila Martau grants you a license to use the SOFTWARE on maximum 2 USB memory sticks.

2.6 Site license

Gavrila Martau grants you a license to use the SOFTWARE on multiple computers for one or more users. The computers can be used concurrently by two or more users. This license type allows unlimitted number of installs, registrations, uninstalls and license transfers as long as the number of registered installations at a time doesn't exceed the number established at the purchase time. This license type, is restricted to the use within one SITE.

3. ACTIVATION

Solely for the purpose of preventing unlicensed use of the SOFTWARE, the program may use the Internet connectivity to confirm that you have a valid license and to comply with the number of licensed computers. You may need to re-activate the SOFTWARE if you modify your computer hardware or operating system. During activation, no personal information is captured or transmitted. Depending of the COMPUTER configuration, the program may request the activation as mandatory or not.

4. MAINTENANCE

Maintenance means that you are granted the opportunity of downloading the current version of the purchased SOFT-WARE and requesting a working license key for the duration of the maintenance period. The maintenance period has a duration of 12 months and starts with the sending of the license key.

5. TRANSFER OF LICENSE

You are allowed to transfer the license from a COMPUTER to another COMPUTER by uninstalling it completely from the old computer and installing and registering on the new COMPUTER. If your license is not a technician or site license, the number of transfers must not exceed 3 per month and 10 per year.

6. TRIAL

This SOFTWARE is not free. When you first obtain a copy of the SOFTWARE, you are granted an evaluation period of not more than 30 days. If you desire to use the SOFTWARE after this period, you must register as described in the documentation accompanying the SOFTWARE. Otherwise you must remove the SOFTWARE from your system.

10.2. You understand and agree that failing to comply with this license agreement your license key will be disabled without notice and without any right of refund or compensation.
